- Advanced driver assistance systems : Nov.22 (Fri.) – Nov.26 (Tue.) * Driver's license required.
- Autonomous vehicle demonstrations : Nov.25 (Mon.) – Nov.26 (Tue.)
- Charging infrastructure and EV/PHV test drives : Nov.27 (Wed.) – Dec.1 (Sun.) * Driver's license required.
